INSTRUCTIONS FOR CONDUCTING EXAMINATION DURING PANADEMIC

- The examination of pending papers of M.A/M.Sc./M.Com Semester I & II Regular & Backlog (Batch 2017) is commencing from 11th of July, 2020 which were pending till date due to Pandemic.
- The student strength is to the maximum of 35 per day in the subject of Chemistry and on one day 51 in Commerce.
- The students having COVID-19 symptoms are not allowed to appear in the examination.
- The Seating Plan should be placed inside the college premises at two or three locations to avoid crowding of students.
- College administration shall ensure arrangement for hand sanitizers outside the examination centre and shall pass on the necessary instructions to supervisory staff and the students to use hand sanitizer before entering in the examination hall.
- The supervisory staff and students should compulsorily wear face masks and should be informed well in advance through digital or any other mode.
- The examination halls/rooms should be properly fumigated in and outside before commencement of examination.
- The seating plan should be prepared in such a way that both horizontal and vertical physical distance is maintained by keeping two alternate seats vacant in both the directions.
