
The appointment of above candidates shall be governed by the following terms and conditions:

1. The appointment shall be subject to ratification by the University Syndicate;
2. The appointment of the candidates shall be governed by 'New Pension Scheme' in light of SRO-400 of 2009 dated: 24.12.2009.
3. The appointees must join within twenty-one (21) days from the date of issuance of this order;
4. The appointees shall submit his joining report in the Office of Registrar;
5. The selection of the candidates is provisional, subject to the verification of the following documents which shall be submitted by the candidates in original in Registrar office:
 - a. Academic Qualification, marks cards, NET/SLET/PhD etc and Experience Certificate(s),
 - b. Date of Birth Certificate;
 - c. Relevant category certificate, as may be applicable to the appointee;
 - d. Physical Fitness Certificate from a Government medical officer;

- e. Certificates from the concerned authority to the effect that no loan under self-employment scheme has been availed by the appointee;
 - f. An affidavit, duly sworn-in before the 1st Class Magistrate to the effect that he is not presently employed in any Government/ Semi Government Department and also, he is not involved in any Criminal case / offence.
 - g. No Objection Certificate from his previous employer, if applied through proper channel.
6. The salary of the appointees shall be drawn and disbursed only after the receipt of satisfactory report in respect of genuineness of the certificates listed under condition 5 above;
 7. The appointees shall be on probation for a minimum period of two years from the date of their joining.
 8. If any information furnished by the appointee/s is found incorrect / false or has been wilfully suppressed, he shall be liable for termination from services and /or any other action as warranted under rules.
 9. The service conditions of the appointees shall be governed by the rules & regulations of the University (as amended from time to time) together read with UGC Guidelines and J&K CSR whichever is applicable.
 10. **The appointment of the above candidates shall be subject to the outcome of the writ petition(s), if any, pending adjudication before any Competent Court of Law.**
