1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption. 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

#### 3. Buyer Added Bid Specific ATC

- 1. The bidder should be approved /recognized/registered by Go vernment for providing manpower services. A copy of the rele vant certificate should be attached. In addition to above:
  - 1. Service providers must be registered under labour laws.
  - 2. Service providers must be registered with the labour fund commissioner
  - 3. Service providers shall comply with the statutory provision s of the labour laws like minimum wages, EPF,ESI etc.

2. The bidder must comply with the requirements, such as registrat ion with ESI, EPF, PAN/TIN/TAN & GST, and submit proofs thereof. T he firm is required to submit IT returns for the last three years and have a minimum turnover of at least Rupees 1 crore a year. Any bi d that's without the prescribed EMD shall be out rightly rejected ex cept those allowed under provisions of law, successful bidder shall also have to submit Performance Security. (Rule 170 of GFR 2017)

3. The bidder must have been in existence for the last 3 years. (Att ach a copy of relevant certificates, registration details, etc.) and sh all have experience in the job with educational entities, autonomou s organizations and other government departments preferably in JK UT

4. It shall be the sole liability of the agency/service provider to com ply with the provisions of the labour laws/ Employees Provident Fun d Act, Employees State Insurance Act, Minimum wages Act and any other labour laws in force and this office shall not , in any way be li able for the Acts of omission and commission of the agency/service provider which may contravene with the provisions of any of the la ws in force .

5. The selected Agency/ will have to pay taxes/income tax on the c ontract amount as applicable. If any additional rates/taxes/income t ax has to be paid, that shall be borne by the Agency/Contractor. Ot herwise, it shall be deductible from his payments.

6. The bidder must have the registered address within the geograp hical location of District Srinagar, UT of Jammu and Kashmir.





The complete add ress and contact person details shall be given, and all corresponde nce will be made at this address only. At least one Representative/ Supervisor or above-level personnel should be deployed in the univ ersity who can visit the university regularly.

7. The Agency shall employ adult staff as per the criteria of J&K Go vt.

8. The staff provided by the service provider/ agency shall be boun d to observe all instructions issued by this office concerning genera I discipline and behavior.

9. The Agency/Contractor staff shall not be treated like the staff of Cluster University Srinagar for any purpose whatsoever. The Agenc y shall be responsible for strict compliance of all statutory provision s of relevant labor laws applicable from time to time in carrying out the above job.

10. The Agency shall disburse the wages to the workers through ebank transfer to their respective accounts by 5<sup>th</sup> of every month an d a copy of the payment details will have to be furnished to this offi ce along with the bill preferred to this office every month for paym ent. Non-payment of wages and any malpractice if noticed, will invi te a penalty which may lead to termination of contract & blacklistin g of the firm or any other decision deemed fit by the Competent Au thority. The Agency will also be liable to pay the disputed outstandi ng amount.

11. None of the persons engaged by the Agency shall enter into an y kind of private work at any other location during working hours.

12. Based on the requirement of each job, the personnel supplied b y the Agency for engagement/deployment will be decided by Cluster University Srinagar & the decision of Cluster University Srin agar will be final in this regard. In case Cluster University Srinagar i n its discretion finds any deployed person as not desirable and not suitable for whatsoever reasons will be at the sole discretion of the Cluster University Srinagar and upon so being notified by Cluster U niversity Srinagar the Agency shall be liable to withdraw such perso n(s) forthwith and substitute by a person(s) acceptable to Cluster U niversity Srinagar.

13. Office timings will be as per University norms.

14. The Agency will be responsible for complying with the obligatio ns under the Labour Laws in respect of minimum wages, and vario us other provisions for all its personnel deputed to work for Cluster University Srinagar. The agency shall pay the exact amount faithful ly to the outsourced personnel without any additional deduction ot her than stipulated. Violation of this shall attract a warning at the fi rst instance and may lead to termination of contract on recurring in stances. 15. Cluster University Srinagar shall have no liability whatsoever to wards any other personnel or equipment of the Agency. All statutor y requirements for the workmen are to be borne by the Agency and shall be the sole responsibility of the Agency.

16. In the event of any dispute or difference, the same shall be refe rred for arbitration to the sole arbitrator i.e Hon'ble Vice-Chancellor , Cluster University Srinagar, or his nominee, whose decision shall b e final and binding upon the Parties.

17. The minimum rates of wages and statutory contribution viz. EP F, ESI (wherever applicable), EDLI, and Administrative charges on E PF as notified by the J&K Govt. from time to time shall be paid by the university. However, the contractor will quote for agency charg es in terms of percentage per day per man in the prescribed forma t as legally permissible at the end of the tender document.

18. The agency shall have UAN No. issued by Regional Provident F und Commissioner.

19. The successful agency shall get the ESI ID Cards issued for the staff State Insurance office in favour of the labourers/ manpower as per bill for the month of july 2025 at his own level and the remainin g manpower if any, shall also be issued said cards with one month of award of contract.

20. The Agency will ensure that EPF and ESI (wherever applicable) are credited to individual accounts of the staff and shall attach a m onthly statement on account of EPF/ESI showing details of the empl oyer's contribution, contractual labourers contribution in respect of all deployed contractual persons along with the bill every month su pported by challan/ receipts issued by concerned authorities like EP FO, EDLI offices for verifications.

21. The contractor shall be held responsible for any sort of theft/los s etc. caused due to the negligence of the contractor's staff or due to non-supply of the desired number of persons to the University a nd the same may be recovered from the bill of the contractor.

22. The contract will be initially for a period of 01 (One) year from t he date of signing the agreement.

23. The successful bidder shall abide by the statutory obligations to be followed in the contract for hiring manpower from outsource agencies on GEM portal notified by the J&K Government vide Go vt. order no.08- FD of 2023 dated:04-12-2023 and modifications if any made by the Govt. from time to time.

# 2 4 . All the participants shall upload the

# required documents (without bunching) at th eir relevant places on the portal. Otherwise, their participation will be rejected.

#### 4. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

#### अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

# All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
