## Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

1. The bidder should be approved /recognized/registered by State Govt. for providing manpower services. A copy of the relevant certificate should be attached. Service providers should have a valid license from a competent licensing authority under the provision of the Labour Commissioner, J&K Govt. and submit proof thereof.

- 2. The bidder must comply with the requirements, such as registrat ion with ESI, EPF, PAN/TIN/TAN & GST, and submit proofs thereof. The firm is required to submit IT returns for the last three years and have a minimum turnover of at least Rupees 27 lakhs a year.
- 3. The bidder must have been in existence for the last 2 years(Atta ch a copy of relevant certificates, registration details, etc.)
- 4. The service provider shall be responsible for all the rules and regulations enforceable by Labour Commissioner, J&K Govt.
- 5. The selected Agency/ will have to pay taxes/income tax on the c ontract amount as applicable. If any additional rates/taxes/income t ax has to be paid, that shall be borne by the Agency/Contractor. Ot herwise, it shall be deductible from his payments.
- 6. The bidder must be within a geographical location of UT of Jamm u and Kashmir. The complete address and contact person details s hall be given, and all correspondence will be made at this address only. At least one Representative/ Supervisor or above-level person nel should be deployed in the university who can visit the university regularly.
- 7. The Agency shall employ adult staff as per the criteria of J&K Go vt.
- 8. The Agency shall be responsible for the proper maintenance of d ecorum, punctuality, discipline, and work output.
- 9. The Agency/Contractor staff shall not be treated like the staff of Cluster University Srinagar for any purpose whatsoever. The Agenc y shall be responsible for strict compliance of all statutory provision s of relevant labor laws applicable from time to time in carrying out the above job.
- 10. The Agency shall disburse the wages to the workers through e/bank transfer and Non-payment of wages by and any malpractice if noticed, will invite a penalty which may lead to termination of contract & blacklisting of the firm or any other decision deemed fit by the Competent Authority. The Agency will also be liable to pay the disputed outstanding amount. Cluster University Srinagar shall not be directly responsible for the payment of wages to the employees. It will be the responsibility of the Agency to make a regular payment to the workers engaged by him as per the minimum wages applicable to the State Govt.
- 11. None of the persons engaged by the Agency shall enter into an y kind of private work at different locations during working hours.
- 12. Based on the requirement of each job, the personnel supplied b

y the Agency for engagement/deployment will be decided by Cluster University Srinagar &the decision of Cluster University Srinagar will be final in this regard. In case Cluster University Srinagar in its discretion finds any deployed person as not desirable and not suitable for whatsoever reasons will be at the sole discretion of the Cluster University Srinagar and upon so being notified by Cluster University Srinagar the Agency shall be liable to withdraw such person(s) forthwith and substitute by a person(s) acceptable to Cluster University Srinagar

- 13. Office timings will be as per University norms.
- 14. The Agency will be responsible for complying with the obligations under the Labour Laws in respect of minimum wages, and various other provisions for all its personnel deputed to work for Cluster University Srinagar. The agency shall pay the exact amount faithfully to the outsourced personnel without any additional deduction ot her than stipulated. Violation of this shall attract a warning at the first instance and may lead to termination on recurring instances.
- 15. Cluster University Srinagar shall have no liability whatsoever to wards any other personnel or equipment of the Agency. All statutor y requirements for the workmen are to be borne by the Agency and shall be the sole responsibility of the Agency.
- 16. In the event of any dispute or difference arising out of or in any way touching or concerning this agreement whatsoever (except as to matter the decision of which is specifically provided under this 6 / 8 contract) the same shall be referred for arbitration to the sole ar bitration. Hon'ble Vice-Chancellor, Cluster University Srinagar, or his nominee shall be the sole Arbitrator whose decision shall be final and binding upon the Parties.
- 17. The minimum rates of wages and Statutory contribution viz. EP F, ESI (wherever applicable), EDLI, and Administrative charges on E PF as notified by the J&K Govt. from time to time shall be paid by the university. However, the contractor will quote for agency charg es in terms of percentage per day per man in the prescribed format as provided at the end of the tender document.
- 18. The agency shall have UAN No. issued by Regional Provident F und Commissioner.
- 19. The successful agency shall get the ESI ID Cards issued from the Employees State Insurance office in favour of the labourers/ man power as per bill for the month of march 2022 at his own level and the remaining manpower if any, shall also be issued said cards with one month of award of contract.

- 20. The Agency will ensure that EPF and ESI (wherever applicable) are credited to his employee's account and shall attach a monthly statement on account of EPF/ESI showing details of the employee's contribution, contractual labourers contribution in respect of all de ployed contractual persons along with the bill every month support ed by Bank challan for verifications. 21. The contractor shall be hel d responsible for any sort of theft/loss etc. caused due to the neglig ence of the contractor's staff or due to non-supply of the desired n umber of persons to the University and the same may be recovered from the bill of the contractor.
- 22. The contract will be initially for a period of 01 (One) year from the date of signing the agreement.
- 23. The qualifying agency shall be asked to retain the supporting st aff of the last year, whose performance has remained satisfactory

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
