Session-2022-23 PG Programmes (Lateral Entry)
Self-Finance Quota

Consequent upon availability of few vacant seats due to non completion of admission formalities by few candidates, candidates whose credentials are mentioned below are provisionally selected for admission to various **PG Programmes (Lateral Entry)** for the Academic Session-2022-23, under Self-Finance Quota on the basis of Academic Merit obtained by the candidate in 10+2+3 UG Examination, preferences exercised by the candidate for various programmes, and intake capacity for each programme. **The selection of the candidates is strictly provisional subject to the fulfillment of eligibility criteria as determined and fixed by the university.** Selected candidates are hereby informed to report to the office of the Principal of the college allotted as shown against each programme for verification of documents and completion of their admission formalities from 20th February, upto 23rd February, 2023 (4.00PM).

1. The admission of the candidate is subject to production of following supporting documents:
 - I. *Copy of the college Leaving Certificate attested by the Principal or the authorized officer of the college concerned (provisional certificate); Original to be retained by the College;*
 - II. *Self-attested photocopy of Character Certificate issued by the institution, last attended;*
 - III. *Self-attested photocopy of Secondary School Examination (10th Class) certificate as a proof of Date of Birth;*
 - IV. *Self-attested photocopy of 10+2+3 examination (Marks Certificate) of all semesters;*
 - V. *Migration certificate (wherever applicable);*
 - VI. *The eligibility of the pass out candidates of 10+2+3 class other than Cluster University Srinagar shall be determined subject to the submission of Original Migration certificate from respective institutions and equivalence certificate of 10+2+3 from concerned university (if required). The Admission Committee shall accordingly check the status of the university prior to their admission to the course in the respective Colleges.*
2. The Principal of the college shall ensure that all the selected candidates are eligible to the programme in terms of the notification issued by the university
3. After verification of the documents, the Admission Committee of the College shall issue authority slip to the selected candidates for deposition of "Prescribed Annual Admission Fee in the university chest". It is mandatory for college admission committee to submit university copy of the bank challan to the university so that subsequent selection list can be prepared.
4. Fee Details are available on University website: www.cusrinagar.edu.in.
5. Any candidate who fails to complete the admission formalities within the above dateline shall forfeit the claim for admission and seat will be filled by the next candidate in order of merit.
6. Admission Committee of all the colleges shall collect original documents from the candidates and submit the same in the admission section of the university.

7. All the Selection Lists shall be available on the University website www.cusrinagar.edu.in. Students are directed to check University website regularly.
