# Syllabus and Selection Criteria for the Post of Assistant Registrar Cluster University of Srinagar

### Notice for Scheme of Examination/Syllabus

It is hereby notified for the information of all concerned candidates who have applied for the post of Assistant Registrar vide advertisement notification No: 7-CUS of 2025 dated: 16-09-2025 that the syllabi for written examination is notified as per the details given in Annexure "A", which shall consist of two parts as detailed below:

Part	Title(s)	Max Marks	Min. qualifying marks
A	Educational Administration and Management	50	20

The written examination shall comprise of 100 Multiple Choice Questions (MCQs) to be attempted in 100 minutes. There shall be negative marking of 0.25 marks for each incorrect answer. Candidates are required to secure a minimum of 40% marks in each Part (Part A and Part B) separately to qualify for consideration in the final merit list. Merely securing an aggregate qualifying score without meeting the minimum 40% in both parts will not make a candidate eligible for shortlisting. 20 candidates shall be shortlisted for one post and 05 more candidates for every additional post". The final selection for the posts shall be as per the following criteria:

Written Test (80 Marks) Interview performance (20 Marks) Total (100 Marks)

Curriculum and Evaluation of Teaching and learning, Human relations in Educational Administration. General Intelligence/Reasoning: Logical Reasoning and Analytical Ability – Verbal and Non-Verbal (analogies, similarities, differences, space visualization, visual memory, discrimination, observation, relationship, concepts, arithmetical reasoning, verbal and figure classification,

arithmetical number series), Decision making and Problem Solving, General Mental ability.

English Language and Comprehension: This portion will test the candidate's understanding of the English Language, its vocabulary, grammar, sentence structure, synonyms, prepositions, antonyms and its correct usage, passage completion, transformation, active & passive voice, spelling test, idioms & phrases, error correction etc.

Arithmetical and Numerical Ability: Basic Numeracy (number system, Simplification, Decimals, Fractions, L.C.M., H.C.F., Ratio & Proportion, Percentage, Average, Profit & Loss, Discount, Simple and Compound interest, Mensuration, Time and work, Time and Distance, Data Interpretation (charts, graphs, tables, data sufficiency etc.)

Computer Literacy: Basic Applications of Computer and its components, Fundamentals of computer sciences, Hardware & Software, Concept of Open-Source Technologies, Input & output Devices, Knowledge of MS Office, PDF, Internet and E-mail, E-Office, Digitization, Concept of Computer and Internet security protocol, Terms and Abbreviation used in IT, Role of Information Technology in Governance.
